

Beaufort County Parks and Recreation Pool Policy (12/12/2019)

ARTICLE I – POOL RULES

- 1. A valid membership pass is required to use our pool facilities. Daily passes may be purchased by Beaufort County residents (tax payer status determines fee), and out of county or state residents. Weekly, monthly, or yearly passes may only be purchased by Beaufort County tax payers. Proof must be provided. Participants must check in at the front desk to gain entry into the facility. Using another participant's pass to gain access is prohibited.
- 2. Youth under the age of 10 must be accompanied by an adult 16 years or older. Youth may not enter the pool when schools are in session (this excludes home school students).
- 3. Life jackets brought into the facility must be coast guard approved. Any child under the age of 8 with a life jacket on must be within arm's length of a supervising adult.
- 4. Daily entrances are limited to twice daily. Once a participant leaves the facility, that participant must wait a minimum of 3 hours before they are allowed to re-enter.
- 5. Entering and exiting the facility is limited to the main entrance only. Sliding glass doors are not to be used as an entrance or exit, unless there is an emergency.
- 6. Bathing attire must be worn appropriately (No thong bathing suits). No cotton is permitted in the pool. Only spandex clothing is allowed.
- 7. Beaufort County Parks and Rec is not responsible for any lost or stolen items brought into our facilities.
- 8. Food, gum, and drinks are not allowed on the pool deck or in the pool. Water in a closable plastic bottle may be brought into the facility (No glass).
- 9. Alcoholic beverages, smoking, and tobacco products are not allowed on Beaufort County property.
- 10. No running or horse playing on the pool deck or in the bathrooms.
- 11. Exercise equipment is for swim team use only (when coach is present).
- 12. Starting blocks are for preapproved groups only.
- 13. Profanity or vulgar language is not allowed. Consequences are as follows:
 - 1st offense Warning
 - 2nd offense Suspension from the facility for 1 week
 - 3rd offense Suspension from the facility for 1 month
 - Any offense after the above could result in permanent suspension from the facility
- 14. No pets are allowed into the facility (with the exception of a service animal).
- 15. Beaufort County Parks and Rec staff reserves the right to remove any person from the property for violation of the pool policies.

- 16. Violations can also result in your membership being suspended or terminated.
- 17. Organized practices and trainings are prohibited unless they are affiliated with a Beaufort County Parks and Rec program, or scheduled through Beaufort County Parks and Rec.
- 18. No grills, coolers, or sound systems are permitted in or around the facility.
- 19. Swim diapers are REQUIRED. Diaper changing on the pool deck is prohibited.
- 20. Facility will close at the sight of lightning or sound of thunder. Facility will remain closed for 30 minutes from the last sight of lightning or sound of thunder.
- 21. Fees and policies are subject to change.

I have read and understand these policies. I fully understand the terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I also understand Parks and Rec reserves the right to remove anyone from the facility at any time. Parks and Rec also reserves the right to close the facility at any time and for long periods of time for Parks and Rec programs or events.
